



*Sirocco Golf Club*

Sirocco Golf Club offers a limited number of Annual Corporate Memberships each season. Corporate Memberships are available in three (3) different packages;

| 1 — Package of Thirty (30) starting times for two (2) players with power cart | \$5700.00 + tax |
| 2 — Package of Forty (40) starting times for two (2) players with power cart  | \$7600.00 + tax |
| 3 — Package of Fifty (50) starting times for two (2) players with power cart  | \$9500.00 + tax |

- One unit will be defined as 18 holes of golf for two adults and one power cart rental. For a third person you have the option of deducting another unit from the package or pay the guest rate.
- Tee Times can be used anytime Monday – Friday not including holidays and after 12 p.m. on weekends and holidays. Sirocco Golf Club opens in late April and closes mid October.
- A 24 hour cancellation policy is in effect. If your tee time is not cancelled / changed a minimum of 24 hours in advance your account will be charged accordingly (i.e. billed for number of players booked; not for the number of players that show up).
- A maximum of two (2) starting times (8 players) can be used in any one day without authorization from Sirocco management.
- **Unused times can be carried over for one season only if another corporate package is purchased. If a new package is not purchased all benefits and perks are removed but the designate will be able to use up the remaining rounds by booking as a public player. If a new package is purchased the remaining rounds will be added to the new package.**
- The Primary Cardholder may play in either Men's night or Ladies' night at no charge.
- The Primary Cardholder has unlimited use of the practice facilities.
- Preferred starting times may be booked up to seven (7) days in advance by calling the Pro Shop or on line through the Sirocco website.
- Corporate Members and their guests may use the practice facilities before your round.
- Signing privileges are available (subject to approved credit) for Primary Cardholder. All food and beverage as well as pro shop purchases may be charged to a club account that must be paid monthly.
- Signing privileges do not extend beyond the Sirocco Golf Club.
- Corporate Members are responsible for keeping their chits acquired from the Pro Shop and food & beverage departments. A processing fee of \$25.00 per month will apply should you require copies.
- Corporate Members are responsible for keeping track of the number of tee times used. Any tee times which exceed the number of tee times purchased will be billed to your account at the regular green fee rate.
- Corporate Members should have their picture taken or produce a membership card for identification purposes at the golf club. This includes checking in at the Pro Shop and charging to your account in either the Pro Shop or for food and beverage.
- Corporate Members will receive Member pricing on meeting rooms (must be booked in advance and are subject to availability).
- Corporate Memberships are non refundable and non transferable.
- Corporate Members will abide by the clubs code of conduct and Rules and Regulations and be held responsible for the activities of their guests.
- Corporate Members have access to the Members' Locker room and the Members' Lounge.
