2. The Member has applied for and in conjunction with acceptance as an Annual Intermediate Member of Sirocco, agrees to pay to Sirocco the Annual Intermediate Membership Fee of \$1850 plus tax.
3. The balance of the Annual Intermediate Membership can be paid any time before April 1st, 2019. Alternatively, all intermediate members have the option to pay half of the balance before April 1<sup>st</sup>, 2019 and the remaining half before July 1<sup>st</sup>, 2019. Should payment not be made on or before these dates, Sirocco Golf Club reserves the right to terminate all membership privileges as of this date.
4. Membership privileges include unlimited golf anytime Monday – Friday and after 2:00 pm on weekends and holidays, 7 days advance booking, unlimited driving range and practice facility access and a member's charge account. Annual power cart rental is also available. This membership type does not include locker or bag storage privileges.
5. A Member shall adhere to all Terms and Conditions and the coincidental Rules and Regulations.
6. Intermediate annual members cannot compete in any member events including Club Championships, Opening & Closing Scrambles, Ryder Cup, Mixed Pairs and Match Play.
7. Can participate in men's and ladies leagues and 2019 Men's Sirocco Open. League and event registration fee is applicable.
8. The applicant acknowledges that in utilizing the Facilities or any privilege or service available arising from Membership, that there is some risk of possible injury. The applicant hereby accepts any and all risks of injury to the applicant, his or her guests and his or her family suffers or sustains while using or employing the Facilities or while involved in any event or activity incidental to Membership in Sirocco.
